

**Decree of the Ministry of Agriculture of 31 May 2002  
Implementing Act No. 452/2001 Coll., on the Protection of Designations of Origin  
and Geographical Indications and on the Amendment to the Act on the  
Consumer Protection**

The Ministry of Agriculture stipulates in accordance with Section 26 of Act No. 452/2001 Coll., on the protection of designations of origin and geographical indications and on the amendment to the Act on consumer protection (hereinafter “the Act”), with regard to the wording of Section 5, paragraph 5 of the Act:

1.—(1) List of agricultural products and foodstuffs intended for human nutrition, for inclusion of which in the Register of designations of origin and geographical indications (hereinafter “the Register”) a specification shall be presented according to Section 6 of the Act, is included in Annex No. 1.

(2) List of agricultural products not intended for human nutrition, for inclusion of which in the Register a specification shall be presented according to Section 6 of the Act, is included in Annex No. 2.

2. This Decree enters into force on 1 July 2002.

**List of Agricultural Products and Foodstuffs Intended for Human Nutrition**

Beer

Natural mineral waters

Beverages made from plant extracts (especially juices, extracts, leaches and substances that are obtained from natural plant materials, fresh plants or dried or otherwise treated parts of plants)

Mill products, bakery products, candy and confectionary products<sup>1),2)</sup>

Natural gums and resins

Fish, crustaceans and molluscs<sup>3)</sup>

Other vegetable oils, crude, refined or purified

Edible fats and oils, of animal or vegetable origin, hydrogenated, refined as well as not refined, however not further processed<sup>9)</sup>

Margarines and other processed edible fats<sup>9)</sup>

Waste materials from processing of animal fats or animal or vegetable waxes

Honey<sup>2)</sup>

Sugar (of beet or cane) in solid state<sup>2)</sup>

Other natural sweeteners, fluid sugar and fluid products from sugar<sup>2)</sup>

Molasses, whether or not decolourised<sup>10)</sup>

Flavoured or coloured sugar<sup>10)</sup>

Flavoured or coloured other natural sweeteners and molasses<sup>10)</sup>

Cocoa beans or cocoa pulp, raw or roasted<sup>2)</sup>

Other products from fruit, vegetables or other parts of plants

Grape must, in fermentation or with fermentation arrested otherwise than by the addition of alcohol
